<b>Name of Scheme</b>	<b>Pradhan Mantri Fasal Bima Yojana (PMFBY)</b>
<b>Sponsored by</b>	Department of Agriculture & Farmers Welfare, Govt. of India, in collaboration with Govt. of Assam (Centrally & State Sponsored)
<b>Beneficiary Type</b>	Small & Marginal Farmers, Individual Farmers (Loanee & Non-Loanee)
<b>Introduction / Objective</b>	PMFBY is the flagship crop insurance scheme of the Govt. of India, designed to provide financial support to farmers in case of crop loss due to natural calamities, pests, or diseases. Notified crops for Kharif Season are Jute, Sali Paddy and Black Gram and for Rabi Season Boro paddy, Mustard, Potato, Sugarcane and Maize. The scheme helps stabilize farmers' income, promotes risk coverage, and supports sustainable agriculture.
<b>Key Features</b>	<ul style="list-style-type: none"> <li>• <b>Affordable Premiums:</b> 2% (Kharif), 1.5% (Rabi), Farmer share only Rs. 100/- up to 1.00 Ha. Premium increases above one Ha Crop area.</li> <li>• <b>Govt. Support:</b> Balance premium shared by Centre &amp; State</li> <li>• <b>Comprehensive Coverage:</b> From sowing to post-harvest losses</li> <li>• <b>Prevented Sowing:</b> Indemnity up to 25% of Sum Insured-</li> <li>• <b>Direct Benefit Transfer:</b> Claims credited directly to farmers' bank accounts</li> </ul>
<b>Eligibility</b>	All farmers (loanee & non-loanee) cultivating notified crops in notified areas- Compulsory for loanee farmers with Crop Loan/KCC- Eligible for owners, tenants, sharecroppers, lessee farmers- Enrollment must be done before sowing/within notified timelines
<b>Application Process</b>	Farmers can apply through <b>CSC, Banks, Agriculture Offices, or online (<a href="http://www.pmfby.gov.in">www.pmfby.gov.in</a>)</b> - Premium for loanee farmers auto-deducted by banks- Non-loanee farmers must submit required documents during enrollment
