INVITING EXPRESSION OF INTEREST

Sealed Expression of Interest (EoI) affixing Court fee stamp of Rs. 8.25 (Rupees eight and paise twenty-five) only are hereby invited from reputed, registered and experienced outsourcing agencies/firms for providing manpower services for engagement of 8 (Eight) Technical Assistants and 1 (One) Multi-Tasking Staff (MTS) for the District and 6 (Six) Charges under Morigaon District in connection with official works relating to Census activities.

Interested agencies/firms having valid registration certificates, GST Registration, PAN, Labour Licence, EPF & ESIC registration and experience in manpower supply services may submit their EoI along with all supporting documents upto 2.30 PM 20/05/2026. The EoIs will be opened on 20/05/2026 at 3.00 PM.

Terms & Conditions:

1. The engagement of manpower shall be purely on short-term contractual basis for a maximum period of 18 (Eighteen) months.
2. Scope of Work:- The personnels shall be engaged in work related to Data collection and other Census related work as per instruction received from Government.
3. The manpower should be suitably qualified and capable of handling digital applications and other related works for Census 2027.
4. The maximum monthly remuneration shall be: a) Rs. 25,000/- per month for Technical Assistant. b) Rs. 18,000/- per month for MTS.
5. No additional financial liability other than the approved remuneration shall rest upon the Government after completion of the engagement period.
6. The hired manpower (Technical Assistant or MTS) will not be entitled to any claims, rights, interests or further benefits in terms of regularisation or consideration of further appointment to any post, including any claims for any casual, ad-hoc, temporary or regular service in the Government.
7. The outsourcing agency shall be responsible for all statutory obligations and deductions including EPF, ESIC, Labour Laws, Taxes and other applicable liabilities as per Government rules.
8. Payment to the engaged manpower shall be made only through the outsourcing agency and no direct payment shall be made by the office authority.
9. The authority reserves the right to accept or reject any or all EoIs without assigning any reason thereof.
10. The engaged persons should be of Good moral character without having any criminal records.
11. The Agency shall be responsible for the performance of the engaged personnels.
12. In case of default or unsatisfactory service on breach or infringement, authority reserves the right to terminate the contract.
13. Payment will be made only subject to availability of fund.
